NOTE: -- All Suspensions REQUIRE a conference with the principal. Students may be REFUSED RE-ENTRY if parent refuses to meet with the principal or principal designee.
 --Authorities may search students and school properties for possession of alcohol, drugs or stolen goods when reasonable suspicion or cause exists. Lockers belong to the school and random searches may be done.
 --Classroom teachers will develop classroom behaviors and expectations and make sure they are known by students.
 --Classroom disciplines shall be developed by each teacher and posted on the wall.
 --Only school approved hats may be worn. Other hats will be confiscated and returned to parents only.
 --Gang related apparel and paraphernalia is prohibited on school grounds.
 --Expulsion hearings are held by the Pierce Board of Education.
 --DART: 3 unexcused absences (suspensions) will result in letters to DART. At 5 unexcused absences a referral is sent and a DART hearing is held.
 --A violation of dress code will be considered defiance and disciplined under code 48900K, willingly defying authority.
 --Bus consequences for referrals will be handled in the following order: Warning, 3 days off of the bus, 5 days off of the bus, 9 weeks off of the bus, the rest of the year off of the bus.

Mandatory Recommendation of Expulsion:

1. Education Code Section 48915(a) identifies grounds on which a recommendation for expulsion must be made. These grounds are:
 - a. Causing serious physical injury to another person except in self-defense
 - b. Possessing a knife, explosive, or other dangerous object of no reasonable use to the pupil.
 - c. Unlawful possession of any controlled substance listed in Health and Safety Code Section 11053 et seq., except for a first offense for the possession of not more than one avoirdupois ounce of marijuana, other than concentrated cannabis.
 - d. Robbery or extortion.
 - e. Assault or battery, as defined in Section 240 and 242 of the Penal Code, upon any school employee.
